Automobile Service Station ONLINE Renewal Instructions ** A new online process for business licensing applications and renewals has been implemented.

Requirements for renewing the above licence(s):

☐ 1. <u>Licence Application Form</u>

Business and owner information to be entered online.

☐ 2. <u>Certificate of Insurance</u> - completed insurance form to be uploaded online

The insurance form <u>must be completed and signed by your insurer</u> showing evidence of \$2,000,000 (minimum) Commercial General Liability. It is the business owner's responsibility for uploading the insurance certificate on the online application form.

☐ 3. Class B & Class F Licences Require a Licenced Mechanic

(copy of Ontario College of Trades Licence)

Provide proof of one Licenced Mechanic on staff for **Class "B"**Provide proof of one Licenced Body person on staff for **Class "F"**

- ☐ 4. <u>Fee</u> Dependent on Class(es)* (*See Below)
 - Expiry Date January 31st of each year

An Automobile Service station licence may be issued for one or more of the following classifications.

CLASS A: Minor Service/Repair Shop \$243.00

Includes any of the following:

- a) where gasoline, oil, or lubrication is dispensed or electric or hybrid vehicles are charged (excluding employer provided dispensing stations)
- b) Minor automotive parts, supplies and accessories are kept for sale
- c) Tire instatallation and Sales
- d) Minor repairs to Motors vehicles (window tint, electronic installations and/or car detailers)

CLASS B: Major Repair and Servicing \$243.00

Includes any Premises used for the repair and servicing of Motor Vehicles.

CLASS C: Out-of-Town Car Rentals \$243.00

Includes Out-of-town car rentals

CLASS D: Car Wash \$243.00

Includes any Premises used for carrying on the business of a Car Wash whether by mechanical means, non-mechanical means or coin operated

CLASS E: Renting, Leasing, Buying, Selling \$243.00

Includes any Premises used for carrying on the business of renting,

leasing, buying or selling of new or used Motor Vehicles.

CLASS F: Autobody Repair, Painting \$243.00

Includes any Premises used for carrying on the business of repairing, rebuilding or painting of the exterior portions of Motor Vehicles.

Once your application is reviewed, a link to the payment option will be sent to the email provided on the application.

** Late Renewals are subject to \$50 late fee**

Once your application has been reviewed and approved your payment will be processed and your licence will be mailed out.
