

Carnivals and Circuses

Requirements for obtaining the above licence:

- 1. **Licence Application Form**
The attached form must be completed and signed by the owner of the business.
- 2. **Zoning Approval** **Flower City Community Campus**

This approval is to be stamped on the Licence Application and the Site Plan which indicates the exact location where you will be set up on the property. Please contact the Zoning Department as soon as possible to confirm that the location you have chosen is zoned to permit your intended use. In the event you require a Committee of Adjustment decision, this process can take several months to complete and will require an additional fee. - 3. **Certificate of Insurance**
The attached form must be completed and signed by your insurance provider. Location of the Carnival/Circus must be indicated on Insurance form. It is the business owner's responsibility to upload insurance certificate on online application.
- 4. **Articles of Incorporation and/or Business Registration**
 - (master business licence is required when a business is operating as a different name from the corporation, unless the business is a franchise)
- 5. **Written Permission from the Property Owner**
You must provide a letter of permission from the property owner granting you permission to set up on their property. The date(s) and exact location must be specified.
- 6. **Workplace Safety and Insurance**
Submit proof, to the satisfaction of the Licence Issuer that all workers and employees are protected under the provisions of the *Workplace Safety and Insurance Act, 1997*, S.O. 1997, c.16, as amended;
- 7. **Copy of Emergency Plan -**
Must be approved by the Fire Department 905-874-2700 and the Animal Services Department 905-458-5800 ext. 63192
- 8. **Copy of Technical Standards & Safety Authority Certificate.**
- 9. **Copy Ontario Amusement Device Permit for all Rides**
- 10. **Animal Services Approval (for Circuses)** 905-458-5800 ext. 63192
You must call to arrange for an inspection by Animal Services. Prior to the issuance of a licence written approval from Animal Services must be received. Please note there may be an additional fee for an Animal Services Inspection.
- 11. **Hydro One Brampton Approval – 1-877-372-7233**
In the event the premise will be equipped with hydro, you must call and arrange for an inspection by Hydro One Brampton. Prior to the issuance of the licence, written approval from Hydro One Brampton must be received.
***There may be separate fee for this inspection.**
- 12. **Fee - \$248.00 per event (7 days)**

***In the event you will be constructing a tent or other temporary structure, you will require a building permit. Prior to the issuance of the licence, written approval from the Building Department must be received.**

SCHEDULE 7 TO BY-LAW # 332-2013

RELATING TO CARNIVALS AND CIRCUSES

1. In this Schedule:

“Carnival” means a travelling amusement show featuring exhibits, games and rides but which does not feature domestic or wild animals, and includes any similar travelling exhibition;

“Circus” means a travelling entertainment show consisting of, but not limited to, performances by acrobats, clowns and trained animals, and includes any similar travelling exhibition;

“Equipment” includes a tent, shelter, cage, pole, stand platform, seating accommodation, machinery, platform, apparatus, mechanical device, ride, or any other structure.
2. No Carnival or Circus shall be exhibited in the City of Brampton for a period of longer than 7 days.
3. Every Application for a Licence made under this Schedule shall be accompanied by:
 - (a) Written approval for the establishment of the Carnival or Circus from the owner of the lands being used;
 - (b) A map detailing the location of the Carnival or Circus on the property;
 - (c) A certificate of insurance as required by section 37 of this By-law that:
 - (i) is endorsed to include The Corporation of the City of Brampton as additional insured; and
 - (ii) provides commercial general liability coverage in the amount of \$5,000,000.00;
 - (d) Submit proof, to the satisfaction of the Licence Issuer that all workers and employees are protected under the provisions of the *Workplace Safety and Insurance Act, 1997, S.O. 1997, c.16*, as amended;
 - (e) An Emergency Plan in a form satisfactory to the Licence Issuer, Fire Chief and the Animal Services Section of the City.
4. No Equipment shall be erected until the Licensee has complied with Section 3. (d) of this Schedule.
5. Where the Carnival or Circus includes rides or like contrivances, the Licensee under this Schedule shall obtain:
 - (a) A valid and current licence to carry on business in Ontario issued by the Technical Standards & Safety Authority, or its successor; and
 - (b) A valid and current Ontario Amusement Device Permit issued by the Technical Standards & Safety Authority, or its successor, for each ride.
6. A Licensee under this Schedule shall not operate or allow to be operated, rides or like contrivances for use by the public in an improper or dangerous manner.
7. Every Licensee under this Schedule shall:
 - (a) Keep order and, at the Licensee’s own expense, shall keep sufficient number of employees or servants to maintain such order;
 - (b) Ensure that the care, feeding and housing of all the circus animals is done in compliance with the *Ontario Society for the Prevention of Cruelty to Animals Act, R.S.O. 1990, c. O.36*, as amended, and any regulations made under the Act, and with any other applicable laws or requirements; and
 - (c) Ensure compliance with all applicable requirements of the *Health Protection and Promotion Act, R.S.O. 1990, c.H.7*, as amended.
8. Despite any other provision of this By-law, an outdoor circus or carnival shall not operate between the hours of 11:00 p.m. and 7:00 a.m.
