Qualified Opinion

We have audited the accompanying financial statement (Form 4) of Nikki Kaur, candidate for Mayor in the City of Brampton at Municipal election held on October 24, 2022, which comprise the statement of campaign income and expenses, the statement of the calculation of surplus or deficit, schedule 1 - contributions and schedule 2 - fundraising events and activities for campaign period ended December 31, 2022 and note on basis of accounting. The financial statement have been prepared by the candidate based on financial reporting provision of the Municipal Elections Act, 1996 and guidance issued by Ministry of Municipal Affairs.

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion, this financial statement present fairly, in all material respects, the income and expenses of Nikki Kaur for the campaign period ending December 31, 2022, in accordance with the financial reporting provisions of the Municipal Elections Act, 1996 and guidance issued by Ministry of Municipal Affairs.

Basis for Qualified Opinion

Due to the inherent nature of the transactions on electoral campaigns, the candidate derives revenue from contributions from activities that are not susceptible to satisfactory audit verification. Accordingly, our verification of income income was limited to the amounts recorded in the campaign records of Nikki Kaur and we were not able to determine whether any adjustments might be necessary to income and surplus/deficit for the campaign period from August 12, 2022 to December 31, 2022.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the candidate in accordance with ethical requirements that are relevant to our audit of the financial statement in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Emphasis of Matter - Basis of Accounting and Restriction on Use

We draw attention to the Note to the financial statement, which describes the basis of accounting. The financial statement is prepared to assist the candidate to meet the requirements of the Municipal Election Act, 1996 and guidance issued by Ministry of Municipal Affairs. As a result, the financial statement may not be suitable for another purpose. Our report is intended solely for the candidate and city clerk, and should not be used by parties other than the candidate or the city clerk.

Responsibility of Candidate for the Financial Statements

The Candidate is responsible for the preparation and fair presentation of this campaign period financial statement in accordance with the financial reporting provisions of the Municipal Elections Act, 1996 and the guidance issued by Ministry of Municipal Affairs and for such internal control as management determines is necessary to enable the preparation of financial statement that are free from material misstatement, whether due to fraud or error.
